- The applicant must have a minimum average pass mark of 60% in order to qualify for a bursary.
- The applicant must be a biological or legal dependant of Rosond employee.
- Priority will be given but not limited to previously disadvantaged bursars who are planning to study full-time towards an undergraduate degree or diploma in an area that falls within the scarce and critical skills requirements of ROSOND.
